THE UTILITY OF STUDY

As per the survey in 2016, the crimes by women are as high as 3 lakhs under the Penal Code, Special & Local Laws (SLL). The statistics of 2015 about the prisoners in India shows a total of 4, 19,623 persons in jail & women prisoners make up to 4.3% of this figure Out of 1,401 prisons in our country, only 18 are solely for women sheltering 2,985 prisoners. Thus, a majority of women prisoners are housed in women's enclosures of general prisons. Hence the number of prisons exclusively for women in India should be made available. Secondly emphasis on computerization, training, special provisions, prison inspections, rights of prisoners, after-care services and prison correctional staff should be taken care of. Special care for arresting women is to be taken.

TRAINING MODULES

Training Policy and Curriculum, Prison and Probation Interventions, Training for first line practitioners is a must in Prisons. Training Manual of Basic Course for Prison Warders and Training Modules for Indoor Purpose like Basics of Criminology, Victimology and Penology, Basics of Psychology, Basics of Sociology and Social Work, Criminal Laws and Minor Acts, Knowledge of Constitution of India and Human Rights, Technology in Prison Administration are an aid used in prisons. Training Modules for Outdoor like Physical Efficiency Training, Drill without Arms, Drill with Arms, Guards and Sentries, Crowd Control Drills and Techniques, Training Manual of Basic Course for Prison Warders, the Think Tank for Indian Police Promoting Good Practices and Standards Weapon Training, Firing Practice, Unarmed Combat and Self-defence Techniques, Additional Skills and Fitness Training are made available. Training Module for Field Visits, Training Modules for Specialized Short-term Programmes, Personality Development, Prison Emergencies and their Management, First Aid and CPR, Building Maintenance and Electrical Safety are available.

INFRASTRUCTURE REQUIREMENTS IN JAIL

Building better jails through Smart Technology and Training is a task in itself. A smart corrections facility is required to perimeter lighting and fencing or the ability to intercept illegal calls and drone activity, deterring criminal activities within a facility. Radio frequency identification (RFID) technology for inmate movements and alerts the staff needs a good smart work. Connected building systems with a single interface to monitor systems and equipment throughout the facility and Connected systems generating data and continually make complex decisions that contribute to improved building efficiency, comfort, and safety is required for smart prisons. Creating smart jails begins with the identification of challenges specific to a facility.

TRAINING SCHEDULES FOR TRANSFORMATION

Identifying the needs of women prisoners and addressing discrimination is one of basic and most important factor that should be taken care in prisons. Their health, safety, security, rehabilitation asks for quick and planned training schedules for transformation.
